Federal Work-Study Spotlight

Take a look at the awesome work our students are accomplishing at the University Testing Center.



The University Testing Center soft launched in August 2021 in the basement of Hodges Hall. For our first day of testing, we had only one team member, Federal Work-Study employee Lillian Adamiec.

Initially, she and I tackled each new testing experience together. As other FWS students joined the team, Lillian helped to train them and became a de facto team leader for our small group. Our team of Federal Work-Study students helped to develop all of our check-in and check-out procedures at the front desk while also identifying areas of improvement. By the end of that first semester we had administered nearly 8,200 exams, including 1,700 finals. We were able to do this largely through the hard work and attentiveness of our staff.

In early spring 2022, it became clear that our business demands were increasing significantly. We hired on several more desk staff members, some through Federal Work-Study and some not. By midterm, we had a desk staff of 11 undergraduate students. The student workers click cohesively and function as a team very well. They organically trade job duties so no one is stuck with the less popular work, trade shifts, volunteer for additional coverage during peak business, and keep the workspace tidy... During finals, it was imperative that test takers know and find their seat assignments quickly, as we turned each seat over five and six times every day. Seating mistakes meant that the next test taker might not have a seat available at the correct time. The student workers developed a process, amongst themselves, to verify seat assignments as they checked in test attendees. Their goal was to improve seating accuracy while also taking some of the coordination burden off of me. Their process worked beautifully. At the end of finals week, we had administered more than 4,100 exams in a five-day period with no major errors. In total, we administered nearly 26,000 exams in the spring semester.

Each day in the University Testing Center brings new surprises and work challenges. It will be interesting to see the solutions the student workers come up with next.
